## DISCLOSURE OF FINAL WITNESS LIST, LIST OF EVIDENCE, AND AFFIDAVITS OF WITNESSES

### I. INTRODUCTION

1. Under Article 61(3) of the Rome Statute, relating to the hearing to confirm the charges on which the Prosecutor intends to seek trial:

Within a reasonable time before the hearing, the person shall:

- (a) Be provided with a copy of the document containing the charges on which the Prosecutor intends to bring the person to trial; and
- (b) Be informed of the evidence on which the Prosecutor intends to rely at the hearing.

### II. SUBMISSIONS

2. In the Situation in the Democratic People’s Republic of Korea in the Case of *Prosecutor v. Kim Jong-Un*, the Office of the Prosecutor (“Prosecution”) has provided to the International Moot Tribunal (“IMT”) Pre-Trial Chamber I with Public Version of Confidential Annex A entitled “Document Containing the Charges.”<sup>1</sup>

3. The Office of the Prosecutor hereby provides its Final Witness List in the Public Version of Confidential Annex B, List of Evidence in the Public Version of Confidential Annex C, and an Affidavits of Witnesses in the Public Version of Confidential Annexes D.1-D.5.

4. The Prosecution intends to call five witnesses, including one expert.

5. The summaries of anticipated testimony provided should not be interpreted as a comprehensive and complete account of each witness’s expected evidence, but a synopsis of salient aspects thereof. The Prosecution, thus, reserves its right to elicit such other and further evidence as is appropriate under the Rome Statute and Rules of Procedure and Evidence.
